Statement of Subcontractors' Employees of receiving H&S training

TRAINING PROGRAM:

1. Threats occurring on the premises of Woodeco:
 - technological, road and rail transport
 - explosive (potentially explosive) and fire hazards
 - flammable materials, installations and extinguishing agents
 - live equipment
 - hot surfaces
 - hazardous chemicals (storage and use)
 - movable and moving parts of machines and devices
 - noise, dust (possibly other harmful factors)
2. Identification, estimation and assessment of work-related risks.
3. Proper securing of workplaces and proper separation of workplaces (level "zero" and higher / lower; coverage of the work area; visibility of the security during the day and night)
4. Rules for the preparation and conduct of works that require a written order (work registers).
5. Rules for preparing and carrying out work at height (ways and methods of securing).
6. Principles of preparing and carrying out work on power devices (written order).
7. Work in reservoirs and channels on a written order.
8. Rules for the preparation, protection and conduct of fire-hazardous works.
9. Organization of work with other teams (e.g. renovation) - cooperation, coordination, communication.
10. Medical first aid.
11. Mental and physical condition of employees.
12. Instructions for internal transport and traffic rules on internal roads - including safety rules for entering/passing through passages, roads, near working forklifts, loaders and other technological equipment.
13. Own safety of the subcontractor's employees and work culture:
 - risk assessment before starting work
 - work pace, principles of social coexistence
 - handling of doubtful situations
 - attention to proper and effective communication
 - safety rules related to using phones while moving
 - use of appropriate work clothes (including cleanliness and quality of reflectiveness) and footwear
 - application of appropriate means of individual and collective protection
 - identification of potentially accidental events and dangerous behaviors (near miss)
 - reacting to noticed threats (reporting, preventing accidents)
 - the use of only operational tools, equipment and devices
 - not making any unauthorized modifications, not using substitute materials / tools, not intended for a given job, unauthorized.
